2016 Federation Forum/Business Meeting

North Raleigh Hilton November 17, 2016

The Federation Forum was opened by Amy-Lynn Albertson, Federation president at 1:30 p.m. Amy-Lynn explained the purpose of Federation. Charissa Puryear, president-elect, introduced administrators from NC State University and NC A&T State University. Those in attendance were: Dr. Fletcher Barber, Dr. Barbara Board, Dr. Rosalind Dale, Dr. Richard Bonanno, Dr. Sheri Schwab, Dr. Mike Yoder, Dr. Tom Melton, Dr. Claudette Smith, and Dr. Meredith Weinstein.

Cameron Lowe explained the new format being used in the forum. A world-café style was used to facilitate a dialogue to empower administration with information needed to help lead our organization. There were six questions for discussion.

- 1. What is going well and needs to be continued?
- 2. Is there anything that Extension and/or Administration is presently doing that we need to stop doing or do differently?
- 3. Identify challenges to your association, team, or entire organization that could be proactively addressed?
- 4. What are your suggestions/ideas for improving challenges you identified?
- 5. How can Federation better represent you to the organization or administration?
- 6. What other ideas or questions would you like Federation to address?

After rotating through the tables and answering the above questions, summaries were given at each table to share the responses. Extension Administrators were provided with an opportunity to share their thoughts and observations from the discussion.

Additional questions from the parking lot were reviewed. They were:

- Does Administration have a plan for salary compression?
 - Dr. Schwab addressed this for NCSU saying that there is a fine line balance through raises, and the career ladder and it is an ongoing process. Timeline for career ladder implementation this relies on funding. Dependent on how someone would move through the levels. Presently, there is not funding to put in the steps. The model can be put in to place without the funding. The current model of title promotion is still in place. Dr. Board addressed this for NCA&T stating that this process can happen faster at NCSU than at NCA&T. NCA&T has to make sure that they tell their story with NCA&T Administration to explain their partnership. This issue is an ongoing process.
- How's the logo coming? (I'd love to move forward with signage and marketing materials.)
- Can admins get a day at conference?
- When will admin support be given a raise?
- Extension needs to include its name in programs to increase name recognition. (Ex. Extension Master Gardeners, Eat Smart Move More with Extension)

North Carolina Association of Cooperative Extension Specialists

In 2016, NCACES continued to build on its theme of recognizing **Excellence**, encouraging **Scholarship**, and providing **Leadership** opportunities for Extension professionals with a special focus on improving communications among all specialists, agents and administrators. We provided three professional development opportunities during the year beginning with an open forum with Dr. Richard Bonanno, the new Associate Dean, CALS & Director, NC Cooperative Extension Service, NC State University. This was followed by a program focus on integrated programming, specifically around local food systems development. We then closed the year with a panel focused on leadership in Extension programming through strong county / campus partnerships. Attendees during these events represented a diversity of departments including representation from both NC State University and NC A&T State University.

At a retreat with our Board of Directors during the summer, we framed a program plan outline for the organization for the next three years. We hope to engage non-campus members through one virtual meeting per year, while maintaining two face to face meetings, one at each university. In 2017, NCACES plans to begin our year with a focus on success in Extension programming through professional development on preparing and delivering ignite presentations.

The **first priority** identified in the 2015 NCACES strategic plan was development of tangible benefits for its members and a mentoring role for the organization. As a special project this year, and at the request of Dr. Bonanno, NCACES surveyed our membership and other specialists for input on NC State University Department Extension Leader (DEL) positions. Based on input from survey results, Dr. Bonanno has reinstated a DEL in every department CALS department.

The Association's annual awards provided a mechanism to recognize Specialists who meet the needs of North Carolinians through developing and delivering excellent programs and those who provide exceptional support to Extension agents. This year's award winners were:
